

KEY POINTS

- Asking average rental rates have grown 20% since Q4 - 2021 in the North Central submarket.
- Net absorption reached back above 100,000 SF after two quarters of slow absorption.
- Two large industrial leases in the fourth quarter took place in the North Central submarket.

SUBMARKET SUMMARY

The North Central market has began to see another jump in absorption activity after two slow quarters. Net absorption increased to just over 100,000 SF, however vacancy climbed to 3.6%. Rates in the North Central market remain the highest outside of downtown Atlanta which jumped \$0.43 in Q4 to \$12.73 PSF. Some of the largest leases include an unidentified tenant who took up roughly 151,000 SF of space at the Forsyth Commerce Center and NCR's 101,000 SF lease in Alpharetta.


