### **KEY POINTS**

- South Atlanta, the largest submarket in Metro Atlanta, continues to grow with 25 buildings totaling 12.9 MSF under construction.
- 36% of year-to-date Metro Atlanta's net absorption came from the South Atlanta submarket.
- Even with declining vacancy rates, the South Atlanta submarket still holds the lowest rental rates in the Metro Atlanta market.

### SUBMARKET SUMMARY

Atlanta's largest industrial submarket keeps growing. South Atlanta delivered 11 buildings in Q4 and had 25 buildings under construction, totaling 12.9 MSF. Six out of Atlanta's ten largest industrial lease deals came from the South Atlanta submarket. South Atlanta industrial market holds the lowest rental rates in the Atlanta market at \$5.75 PSF. However, with growing demand to situate near Atlanta's International Airport, those rates will continue to rise. South Atlanta is maintaining the lowest rental rates in Metro Atlanta, even with declining vacancy rates.


