LEE & ASSOCIATES COMPLETES OVER 1.9 MILLION SQ FT OF COMMERCIAL REAL ESTATE TRANSACTIONS VALUED AT \$128 MILLION DURING THE 1st QUARTER OF 2025

ORLANDO, FL – April 17, 2025—The Central Florida office of Lee & Associates, the nation's largest broker-owned commercial real estate firm, is off to a fast start in 2025 and is pleased to report that it closed over 2.7 million SF of commercial transactions during the 1st quarter of 2025 valued at over \$128 Million, a 38% increase in production from 1st quarter 2024. Some notable deals to report:

Tim Perry, CCIM, SIOR, Senior Vice President and William "Bo" Bradford, CCIM, SIOR, President, represented Prologis in the leasing of two transactions totaling 58,570 SF in Orlando, FL. Bradford represented Clarion Partners in the leasing of 119,684 SF in Ocoee, FL. These leases had a value in excess of \$15.7 million. In addition, Bradford closed on the sale of two Industrial facilities for the Adam Truss Partnership totaling \$5,500,000.

Derek Riggleman, SIOR, Senior Vice President represented Showsmiths in the lease of 41,800 SF of industrial space in Orlando, FL., he also represented GKI II Orlando in the lease of 27,159 SF of industrial to A1 Assets in Orlando, FL. These leases had a value in excess of \$3.9 million.
