
INDUSTRIAL MARKET OVERVIEW


Durham saw exceptional absorption in Q1 2025 at 2.57 million SF-more than doubling Q4's 1.08 million SF. Vacancy edged up to 7.30% as new supply hit the market. Asking rents dipped to \$11.45 PSF, offering value relative to regional peers. Sale prices rose to \$128 PSF, and cap rates tightened to 7.38%. Construction activity pulled back to 3.3 million SF, down from 4.9 million SF. Despite some pricing pressure, the market remains fundamentally sound, supported by strong leasing and investment interest in logistics and manufacturing hubs.
